What Is Included

Payment Schedule

A \$400 deposit is due with this form and reserves your space on a first come first serve basis. The balance including single room supplement and optional activities, if any, is due as indicated on the registration form, which is approximately ninety (90) days before trip commencement.

Cancellation and Refunds

There is a nonrefundable \$200 cancellation charge until the registration deadline as shown on the registration form. Written cancellation is required to process a refund. If canceled, the entire amount paid will be refunded within fourteen days after the tour's cancellation.
